

**PROFESSIONAL SERVICES**

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

**BASIC SERVICES OF FUNERAL DIRECTOR, STAFF AND OVERHEAD ..... \$2,990.00**

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains). Our basic service charge includes, but is not limited to, staff to respond to initial request for service; arrangement conference with family or responsible party; preparation and filing of necessary certificates and permits; placement of obituary notices; planning of funeral arrangements; and coordination of service with cemetery, crematory, vault companies and others, as required. Also included in this charge are overhead expenses relative to our facility such as insurance, maintenance and utility expenses, secretarial and administrative costs, equipment and inventory expenses.

**EMBALMING ..... \$970.00**

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with a viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as a direct cremation or immediate burial.

**OTHER PREPARATION OF THE BODY..... \$355.00**

Our charge includes handling, cosmetology, hairdressing, dressing and casketing.

**STAFF SERVICES AND FACILITIES**

**A. VIEWING/VISITATION .....\$475.00**

Our services will include local transportation of encased remains, visitation setup, placement of encased remains, and supervision and attendance during visitation.

**B. FUNERAL SERVICE AT THE FUNERAL HOME ..\$490.00**

Our services include coordinating the funeral arrangements, supervision of funeral, staff to attend the funeral ceremony, supervision of committal or other disposition service, setup and use of facilities for funeral ceremony.

**C. FUNERAL SERVICE AT OTHER FACILITY .....\$540.00**

Our services include coordinating the funeral arrangement, supervision of committal or other disposition service, equipment and additional staff necessary to conduct funeral at other facility.

**D. MEMORIAL SERVICE AT FUNERAL HOME.....\$475.00**

Our services include coordinating the memorial service, supervision of the memorial service, staff to attend memorial service, setup and use of facilities for memorial service.

**E. MEMORIAL SERVICE AT OTHER FACILITY.....\$500.00**

Our services include coordinating the memorial service, supervision of the memorial service, and additional staff necessary to conduct memorial service at other facility.

**F. GRAVESIDE SERVICE .....\$450.00**

Our services include coordinating the funeral arrangements at graveside, supervision of the graveside service, equipment and staff necessary to conduct the graveside service.

**ADDITIONAL SERVICES**

**FORWARDING OF REMAINS TO ANOTHER FUNERAL HOME/MORTUARY ..... \$2,750.00**

This charge includes removal of remains, basic services of staff, embalming, and necessary authorizations. This charge does not include any rites or ceremonies.

**RECEIVING OF REMAINS FROM ANOTHER FUNERAL HOME/MORTUARY ..... \$1,900.00**

This charge includes basic services of staff, and picking up remains. This charge does not include any rites or ceremonies.

**THE FUNERAL HOME SERVICE CHARGE FOR A TRADITIONAL SERVICE WITH BURIAL IS \$6,645.00. FAMILIES CHOOSING FUNERAL HOME CASKETS AND OUTER BURIAL CONTAINERS WILL RECEIVE AN AUTOMATIC \$1,000.00 DISCOUNT ON THE SERVICE CHARGE. NO DISCOUNTS ARE AVAILABLE IF CASKETS OR OUTER BURIAL CONTAINERS ARE PURCHASED OUTSIDE OF TERRY FUNERAL HOME, INC.**

**IMMEDIATE BURIAL ..... \$2,145.00 TO \$17,145.00**

This charge for immediate burial includes removal of remains, local transportation to the cemetery, necessary authorizations and basic services of staff. This charge does not include the use of facilities and staff for any visitation or ceremony, public or private, prior to burial or casket.

- A. Immediate burial **WITH** casket provided by purchaser ..... \$2,145.00
- B. Immediate burial **WITH** minimum metal casket selected from our funeral home ..... \$3,140.00
- C. Immediate burial **WITH** casket selected from our funeral home (in addition to cost of casket) ..... \$2,145.00

**DIRECT CREMATION ..... \$1,595.00**

The charge for direct cremation includes removal of remains, local transportation to crematory, necessary authorizations, and basic services to staff. This charge does not include the cremation fee, the use of facilities and staff for any visitation or ceremony, public or private, prior to the cremation. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are fiberboard boxes.

- A. Direct cremation **WITH** alternative container selected from our funeral home ..... \$1,745.00
- B. Direct cremation **WITH** minimum casket selected from our funeral home ..... \$2,590.00

Additional charges per hour for staff services and/or use of facilities for partial ceremonies, body donations or other items not included in the above charges..... \$125.00

Losing a loved is an extremely difficult process and during this time of transition, families sometimes become overwhelmed with the urgency and complexity of funeral arrangements. It is our aim to simplify details and avoid confusion, particularly in the hours before a funeral. To avoid any embarrassment to the family, Terry Funeral Home has instituted the following policies.

- A. All contracts must be secured **48 hours** prior to the service by cash, certified bank check, credit card or verified assignable insurance.
- B. Personal checks will be accepted at the time of arrangements and no later than 48 hours prior to funeral service.
- C. Insurance policies that are in the contestability period (less than 2 years) will **NOT** be accepted as security for funerals
- D. The funeral home will not be responsible for any cemetery transactions. Those funds will not be added to our bill, as the cemetery is a separate business. However, Terry Funeral Home will deliver monies on your behalf. All cemetery charges that have to be delivered to the cemetery must be at the funeral home 48 hours prior to the funeral in the form of cash, certified check or money order.
- E. A consultation fee of \$300.00 will be added to contracts in which families downgrade from burial to cremation.
- F. There will be a \$500.00 consultation fee added to transfer if arrangements are made and family uses another funeral home.
- G. The funeral home is unable to change caskets once remains have been casketed.
- H. Our limousines are available for repast for one hour after the meal begins.
- I. Counties outside of Philadelphia have instituted cremation permit fees for each decedent who dies in their county and is to be cremated. You will be advised of the cost of such permit fees, if applicable.

**INSURANCE PROCESSING FEE**

Families choosing to use insurance policies/assignment to pay for funeral services and merchandise will be assessed a 7% insurance processing fee on the total amount of the insurance proceeds being used. Terry Funeral Home, Inc. uses the services of an insurance processing company to quickly process insurance claims and make funds available within the payment schedule established by the funeral home. In order for the insurance processing company to quickly process these claims the 7% processing fee will be included on your contract as a cash advance item because it is money that is paid directly to the insurance processing company and not paid to the funeral home. Your funeral director will explain this process in detail before it is included on your contract. If you choose not to pay this fee, Terry Funeral Home has the discretion to not accept your policy to pay for the funeral services, but will file your insurance claim (s) free of charge as a courtesy.
